## SEASON PASS INFORMATION



### DOROTHY OLSON AQUATIC CENTER RULES

Managers/head lifeguards reserves the right to close the pool early for threatening weather, low attendance, emergencies, cleaning and for unforeseen circumstances beyond our control.

Managers/head lifeguards reserve the right to refuse admittance or to eject any person from the pool premises failing to comply with health and safety guidelines.

No running, pushing or horseplay is allowed. A person is not to be thrown or pushed into or under the water.

Children 12 years of age and younger must be supervised at all times by a responsible person, 16 years of age or older.

Food or drink may not be brought into the facility. A concession stand is available for your convenience. Do not leave belonging at concession tables. Concession tables are for eating and drinking.

Our managers/head lifeguards have the authority to close our facility if the air temperature is 68 degrees or cooler. On days when the weather is not conducive to swimming, our managers/head lifeguards have also been given the discretion to close the pool early if attendance is poor. As a rule of thumb, if attendance drops below 20 guests we will announce that the pool will be closing in 30 minutes if additional attendance is not forthcoming. These attendance figures do not automatically cause the pool to close in 30 minutes but rather gives the manager/head life guards an opportunity to do so based on various factors: i.e.: weather, time of day, etc.

When thunder and/or lightening are first noticed the pool will be evacuated until thirty minutes after the last thunder is heard. If thunder or lightening occurs again within the thirty-minute period, another thirty-minute time limit goes into effect. The facility will close at the discretion of the manager with no refunds due to the patrons.

### POOL HOURS

Open Daily, 12 noon to 7pm

Each season pass holder will need to have a picture taken prior to visiting the DOAC Aquatic Center. There will be no charge for the initial ID card, however there is a \$5 charge for replacement ID's.

- Only parents and their children 17 years and younger, living at the above address are eligible to be placed on the family pass.
